



Beau's Backyard Boarding Client Agreement & Liability Waiver

This client Agreement (the “**Agreement**”) is made by and between Robin Greer and Will Ward, d/b/a Beau's Backyard & Friends Boarding (the “**Kennel**”), and the undersigned pet owner as set forth below (“**Pet Owner**”).

The signing of this Agreement shall remain in full force and effect between _____ and _____ with its terms applicable to the Parties each time Kennel provides services to Pet Owner for pet(s) named _____ (hereinafter individually or collectively “**Pet**”).

1. **SERVICES ENGAGEMENT:** In exchange for the fee paid by Pet Owner, Beau's Backyard & Friends shall provide any or all of the following services: dog boarding, bathing, play time and other related services (the “**Services**”). Pet Owner hereby agrees to pay the rate for Service in effect at the time Pet is checked into the Kennel.

2. **RIGHT TO REFUSE SERVICE:** Kennel staff reserves the right to refuse service to any Pet. All pets under the age of one (1) that are not spayed or neutered will be accepted only at Kennel's sole discretion.
3. **POLICY COMPLIANCE:** Dog Owner agrees to comply with the following policies:
 - a. We require health records and current proof of vaccinations for your dog. These vaccinations must include rabies, Bordetella, and DHLPP from your vet.
 - b. Pets should be current on worming and heartworm preventative.
 - c. Oral medications can be administered during the pets stay but must be in the original package with the pet's name and dosage. We will not provide injections.

4. **KENNEL SAFETY POLICY & REGULATIONS:**
 - a. Our facility consists of eight (8) climate-controlled kennels which are cleaned and disinfected on a regular basis and as needed.
 - b. We do not allow your pets to comingle with other pets unless they are from the same family and we have your permission.
 - c. I authorize my Pet to commingle with other pets at the sole discretion of Kennel and Kennel Staff. _____ (Pet Owner initials)
 - d. In the event we have a pet in our care that might be a good playmate for your Pet, we will seek authorization from both owners before they can play together.

- e. Pets will be inspected during a meet and greet or upon arrival for fleas, ticks, or conditions not acceptable for the health and safety of other pets in our care.
 - f. All pets are required to wear a leash and collar when entering or exiting the facility.
 - g. Adequate outside exercise and play time will be provided weather permitting.
 - h. Your pet and its bedding will be washed as needed.
5. PET OWNER REPRESENTATIONS:
- a. Owner represents that he or she is the legal owner of Pet and whose signature below is sufficient to enter into this Agreement.
 - b. The Pet is in good health, is current on all required vaccinations, has not had any communicable conditions in the last 30 days, and is free from any condition(s) that could potentially jeopardize the health of other animals.
 - c. The Pet has not demonstrated any aggressive or threatening behavior towards any human or other animal and the Pet has not harmed any human or any other animal.

6. LIABILITY RELEASE/WAIVER
- a. Kennel is not responsible for lost or damaged Pet accessories or possessions.
 - b. Kennel is careful to provide adequate supervision for all pets in their care. However, Pet Owner acknowledges that certain risks of injury in the daycare and boarding setting do exist, and Pet Owner agrees to hold Kennel harmless for all injuries resulting from Pet's activities at the Kennel.
 - c. Pet Owner consents to Pet being left **unattended** during the evenings and at other times chosen by Kennel Staff. Pet Owner further acknowledges that Kennel **does not have a fire protection sprinkler system**, and agrees not to hold Kennel liable for injury resulting from the lack of a fire protection sprinkler system.
 - d. Pet Owner acknowledges that animals are unpredictable and that there is a possibility of injury or death to the Pet or to another animal or person, and agrees not to hold Kennel liable for any injuries and or death of the Pet.

7. INDEMNIFICATION LIABILITY: Pet Owner agrees to indemnify, defend and hold harmless the Kennel and Kennel Staff from and against any and all losses, liabilities, damages, fines, penalties, expenses (including reasonable attorney's fees and veterinary costs and expenses) arising from or out of any breach of the representation and warranties, conditions or covenants contained herein or otherwise related to any acts or behavior of the Pet including the injury or death of another animal at the Kennel or injury or death of Kennel Staff.

8. MEDICAL DECISIONS:
- a. In the event that your Pet needs medical care for any injury or illness, and Kennel staff is unable to reach Pet owner, Kennel Staff shall determine the appropriate medical attention your Pet needs up to, and including, Veterinarian care.
 - b. In the event that your Pet dies in the care of Kennel, Pet shall be taken to a Veterinarian and will be maintained there for pick up or further instruction by

Owner. Should Kennel Staff be unable to reach Pet Owner after a reasonable time period, Kennel Staff will decide the method of death care given to the Pet.

9. PET ABANDONMENT: If Pet Owner fails to pick up Pet within seven (7) days of the scheduled pick up date or does not contact the Kennel to extend the Pet's stay, Pet shall be deemed abandoned, and Pet Owner grants Kennel the authority to place the Pet in the care of an animal rescue group or other animal shelter.
10. PHOTOS & VIDEO RELEASE: Pet Owner agrees to allow Kennel and Kennel staff to use the Pet's name, image and likeness obtained while the Pet is in the care of the Kennel, in any form or format, for use, at any time, in any media, marketing, advertising, illustration, trade or promotional materials.
11. GOVERNING LAW: This Agreement will be governed by the laws of the State of Texas. Pet Owner agrees that if there is a lawsuit related to Pet's boarding and other related services, Pet Owner agrees to submit to the jurisdiction of the courts of Potter County, Texas.
12. SEVERABILITY: If any provision of this Agreement is determined to be unenforceable, such provision will be deemed severed and the remaining provisions of this Agreement will continue in full force and effect.
13. UNDERSTANDING OF AGREEMENT: Pet Owner has fully read and understands the terms of this Agreement. This Agreement represents the entire understanding between Pet Owner and Kennel with respect to its subject matter and supersedes any previous communication or agreement that may exist.
